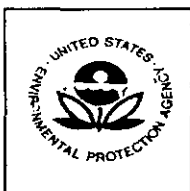



  3. If you do not start with a clean shower, remove heavy build-up or heavy soil prior to spraying with CLEAN SHOWER.
  4. Keep the bottle in your shower as a reminder to continue spraying daily after showering.
- SURFACE SAFETY:** CLEAN SHOWER works safely on most shower surfaces (including tile, fiberglass, porcelain, cultured marble, glass shower doors, vinyl shower curtains, chrome fixtures, grout, silicone caulk and plastic surfaces such as acrylic, polystyrene or ABS, which includes multi-piece wall kits).
