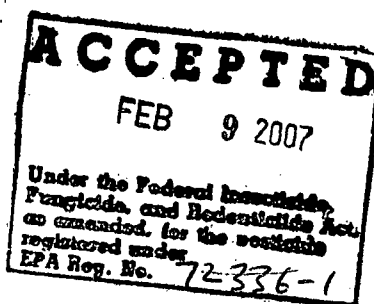

The NOSquito 2-in-1 Power Bait has 2 active ingredients designed to attract a wider range of mosquitoes, including those which may transmit West Nile Virus, encephalitis and other diseases, away from you and your family and to devices that will trap and kill these pests. This lure is intended for use with the Stinger Mosquito Killer and Stinger Mosquito Vacuum. The lure has a slow release and will emit an octenol and lactic acid-scented bait continuously for 30 days.

To install or replace the NOSquito™ by Stinger® 2-in-1 Power Bait:

1. Activate lure cartridge by snapping the cartridge in half, fold over and secure both ends together by interlocking the two small slits found at either ends.
2. For Stinger Mosquito Vacuums, open lure chamber by pulling door by down at the bottom of exhaust ring. Fit the lure cartridge into the chamber and push the lure door closed until it locks in place.

3. For the Stinger Mosquito Killer, open the bulb door and slide the lure cartridge into the holder found on the inside of the door.
4. For best results, replace lure cartridge after 30 days.

Storage: Store unopened attractant cartridge in a cool, dry place.
