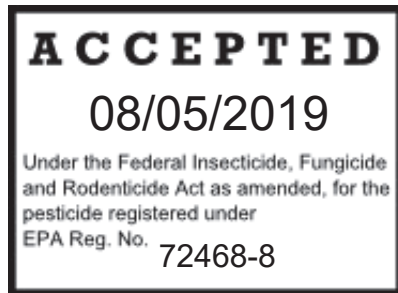

STORAGE AND DISPOSAL

Dispose of wipe in trash after use. Do not flush. Tightly close lid between uses to retain moisture. Do not reuse empty container. Offer empty container for recycling. If recycling is not available, discard container in trash. Do not store near heat or open flame.

Target organisms

Flo-X/Moldwash Pre-moistened Wipes is an effective treatment for cleaning surface mold and mildew stains on non-porous surfaces such as glazed ceramic, glazed tiles, painted areas, varnished areas, sealed wooden flooring, metal framing, sealed window and door framing, bathroom & kitchen fixtures, fiberglass, HVAC vent covers and vinyl.

Common areas for use

Flo-X/Moldwash Pre-moistened Wipes can be used in residential homes, commercial buildings, industrial buildings, schools, hotels, motels, correctional facilities, gyms, automobiles, buses, trains, RVs, marine, cruise ships, yachts/boats.

Preparation of wipe treatment

Flo-X/Moldwash Pre-moistened Wipes is a ready-to-use wipe that can be applied without any preparation.

Direction for dispensing:

1. Always use gloves. Remove lid by lifting upward. 2. Pull towel from the center of the roll and thread through the "X" opening on the underside of the lid. 3. Close lid. Pull towel at 90° angle. 4. Snap the hinged cap back into place to ensure towels stay moist.

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Direction for use:

1. Always use gloves when handling this product and when cleaning surface mold and mildew stains. 2. Pull one towel from container and wipe the area to be cleaned. 3. For very contaminated areas, more than one towel can be used. 4. Dispose of used wipes in a zip-lock bag.
