Use Restrictions: This product is only for control of [to kill] Norway rats, roof rats, and house mice in and around homes, industrial buildings, commercial, agricultural, and public buildings, and similar man-made structures. This product may also be used in transport vehicles (ships, trains, aircraft) and in and around related port and terminal buildings. **Do not apply farther than 50 feet from buildings.** Do not use in edible product areas of food or feed processing plants or other areas where food or feed is commercially prepared or processed. Do not contaminate food/feed handling equipment or place near or inside ventilation duct opening. Do not broadcast bait. Do not sell this product in individual containers holding less than four (4) pounds of bait.

Selection of Treatment Areas: Determine where rodents will most likely find and consume the bait. Generally, these areas will be along walls and building foundations, in cellars and crawl spaces, by gnawed openings, in corners and concealed places, between floors and walls, beside burrow openings and other locations where signs of rodents have been seen. Remove as much alternative food as possible.

Application Directions:

Norway Rats and Roof Rats: Apply 2 to 8 placepacks per bait placement (including deeply into rat burrows) in infested areas. Space placements at 15 to 30 foot intervals. Maintain an uninterrupted supply of fresh bait for 10 days or until there are no longer are fresh signs of rat activity or feeding on the bait.

House Mice: Open pack and apply 1/4 to 1/2 ounce of bait per placement. Use up to one unopened 2-ounce pack only at points of extremely high mouse activity. Space placements at 8 to 12 foot intervals in infested areas. Maintain an uninterrupted supply of fresh bait for 15 days or until there no longer are fresh signs of house mouse activity or feeding on the bait.

Follow-up: While wearing gloves, collect and properly dispose of all visible dead animals and leftover bait. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation occurs, repeat treatment. Where there is a continuous source of reinfestation, establish permanent bait stations and replenish bait as needed.

VOLES

Use Restrictions: Use this product to control only meadow voles [(*Microtus pennsylvanicus*)], pine voles [(*M. pinetus*)] and montane voles [(*M. montanus*)] around homes, and industrial, commercial, agricultural and public buildings. **Do not apply farther than 50 feet from buildings**. Do not use this product within the habitat of threatened or endangered *Microtus* spp. voles, threatened or endangered *Peromyscus* spp. mice, or other threatened or endangered rodents. Do not expose bait on bare ground. All applications must be made by hand. Wear gloves when handling bait or animal carcasses. Do not broadcast bait. Do not sell this product in individual containers holding less than 4 pounds of bait.

Selection of Treatment Areas: Determine areas near buildings where voles or signs of vole activity (girdling of plants, consumption of bulbs, burrow openings and surface runways) have been seen. These areas generally will be in flower beds or under shrubs, bushes or ground cover.

Application Directions: Open pack and load one ounce (half of a pack) of bait into each bait station. Situate bait stations near runways, burrow openings or plants that voles have been damaging. Maintain an uninterrupted supply

of fresh bait for 15 days or until there are no longer fresh signs of mouse activity or feeding on bait. Collect and properly dispose of any carcasses and leftover bait.

Follow-up: While wearing gloves, collect and properly dispose of all visible dead animals and leftover bait.
