**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.  
This label must be in the user's possession at the time of application of this product.

**Read this Label:** Read this entire label and follow all use directions and use precautions.

**Important:** Do not expose children, pets or other domestic animals to this product. To help prevent accidents:

1. Store product not in use in a location out of reach of children, pets and other animals.
2. Apply this product only as specified on this label.
3. Keep pets and livestock out of treated areas until bait has been consumed by the rodents.
4. Dispose of product container, unused, spoiled or unconsumed bait as directed by this label.

**Use Restrictions:** This product may be used to aid in the reduction of flea populations on squirrels of the Genus *Spermophilus* in parks, golf courses, rangeland, pasture, alfalfa, wheat, oats, barley, fruit tree orchards (dormant

season only), non-crop rights-of-way and other non-crop areas. The insecticide in this product acts systemically to aid in the reduction of fleas that infest these rodents. The types of fleas that might be controlled include, but are not necessarily limited to, *Oropsylla idahoensis* and *Hoplopsyllus anomalus*. Apply this product only at times of year when these rodents are readily accepting grains. Bait at a time when rain is not expected for at least four days after the time of baiting. Do not apply bait over roads, walkways or water. Use only for the sites, pests and application methods described on this label.

Wear gloves when applying bait. With detergent and hot water, wash all utensils used for applying bait. Do not use these utensils for mixing, holding or transferring foods or feeds.

**Baiting:** Manually scatter ½ cup of bait (approximately 2 ounces or 56 grams) on ground near each burrow opening being used by ground squirrels. Bait spoons, measuring cups or other suitable implements may be used to measure and distribute bait. Re-apply bait to the same area every other day for 3 to 4 applications. Do not pile the bait; scattering the bait allows the rodents to utilize their natural foraging behavior and limits exposure to livestock and non-target wildlife.

A continuous supply of bait is needed for 6 to 8 days to ensure that all ground squirrels present have opportunity to feed on bait for at least 5 consecutive days. Do not exceed the maximum application rate of ½ cup per burrow for 4 applications.

#### Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in original container in a cool, dry place inaccessible to children and pets. **Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **Container Disposal:** Non-Refillable Container. Do not reuse or refill this container. **{Plastic:}** Triple rinse (or equivalent) then offer for recycling or reconditioning; or puncture and dispose of in a sanitary landfill; or incineration; or if allowed by state and local authorities, by burning; if burned, stay out of smoke. **{Paper:}** Dispose of empty paper box [bag] in a sanitary landfill or by incineration; or if allowed by state and local authorities, by burning; if burned stay out of smoke.
