DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This label must be in the user's possession at the time of product application.

Apply this product only for the sites, pests and application methods specified on this label.

If sufficient quantities of this bait are ingested, the use of this product may aid in the reduction of fleas, including but not necessarily limited to *Xenopsylla cheopis*, that commonly infest listed rodent hosts.

Read this Label:

Read this entire label and follow all use directions and use precautions.

Important: Do not expose children, pets or other non-target animals to rodenticides. To help prevent accidents:

- 1. Store product not in use in locations out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife in tamper-resistant bait stations. These stations must be resistant to destruction by children under six years of age and dogs, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears or other potentially destructive animals or in areas prone to vandalism.
- 3. Dispose of product container, as well as unused, spoiled and unconsumed bait, as specified on this label.

Note: Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets, non-target mammals, or birds may access the bait.

Use Restrictions: Use this product to control only Norway Rats [(Rattus norvegicus)], Roof Rats [(Rattus rattus)] and House Mice [(Mus musculus)], and their infested fleas in and around residential buildings, industrial/agricultural buildings and similar man-made structures, and inside transport vehicles. Do not apply farther than 50 feet from buildings. Do not contaminate food/feed or food/feed-handling equipment or place near or inside ventilation duct openings. Do not use this product to control Peromyscus spp. mice.

Do not sell this product in individual containers holding less than 16 pounds of bait.

Selection of Treatment Areas: Determine areas where rodents will most likely find and consume bait. Generally, these areas will be along walls, by gnawed openings, in or beside burrows, in corners and concealed places, between floors or walls, beside burrow openings and other locations where signs of rodents have been seen. Remove as much alternative food as possible.

Application Directions:

Norway Rats and Roof Rats: Apply 4 to 16 one-ounce bait blocks per bait placement. Space placements at intervals of 15 to 30 feet in infested area. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

House Mice: Apply 1 one-ounce bait block per placement. Space placements at intervals of 8 to 12 feet in infested area. At points of extremely high mouse activity use 2 bait blocks. Maintain an uninterrupted supply of fresh bait for at least 15 days or until fresh signs of feeding by house mice cease to appear.

Follow-up (Rats & House Mice): Immediately replace contaminated or spoiled bait. While wearing gloves, properly collect and dispose of all dead animals and leftover bait. To discourage re-infestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation occurs, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations. Regularly check the stations and replace bait as needed.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a cool, dry place inaccessible to children and pets. Pesticide Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. Container Disposal: Non-refillable container; do not reuse or refill this container. As soon as possible, wash hands thoroughly after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet and change into clean clothing.

Also for pets, if needed, check prothrombin time every 3 days until values return to normal (up to 30 days). In severe cases, blood transfusions may be needed.

Environmental Hazards

This product is extremely toxic to mammals and birds. Dogs, cats and other predatory and scavenging mammals and birds might be poisoned if they feed upon animals that have eaten this bait. Do not apply directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment wash water or rinsate.
