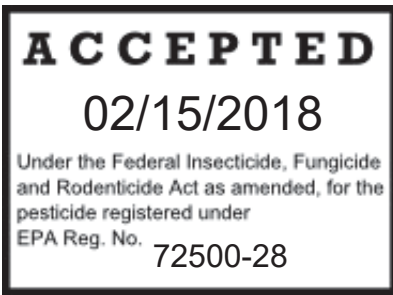

DIRECTIONS FOR USE

Restricted Use Pesticide

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. This label must be in the user's possession at the time of application of this product.

Apply this product only for the sites, pests and application methods specified on this label.

Read this Label:

Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets or other domestic animals to this product. To help prevent accidents:

1. Store product not in use in locations out of reach of children, pets and other animals.
2. Keep pets and livestock out of treated areas until bait has been consumed by the rodents.
3. Dispose of product container, unused, spoiled or unconsumed bait as directed on this label.

Use Restrictions: Use this product to kill flea populations on prairie dogs of the Genus *Cynomys* in parks, golf courses, non-crop rights-of-way and other non-crop areas. The insecticide in this product acts systemically to kill fleas that commonly infest prairie dogs including, but not necessarily limited to *Oropsylla spp.* fleas. Do not apply bait over roads, walkways or water.

Wear waterproof gloves when applying bait. With detergent and hot water, wash all utensils used for applying bait. Do not use these utensils for mixing, holding or transferring foods or feeds.

Treatment Period: Apply bait between September 1 and April 30 of the following year when prairie dogs will most readily take the grain bait.

Baiting: Scatter bait on ground within 6 feet of each burrow opening used by prairie dogs using following application rates and frequency to complete one baiting cycle:

Treatment Day	Bait Application per Active Burrow	Max. Application Rate per Acre (treats 30 burrows)
Day 1	4/5 cup (6.5 oz / 0.4 lbs / 184 g)	12 lbs
Day 8	2/5 cup (3.25 oz / 0.2 lbs / 92 g)	6 lbs
Day 22	2/5 cup (3.25 oz / 0.2 lbs / 92 g)	6 lbs
Total per baiting cycle	1 3/5 cup (12.875 oz / 0.8 lbs / 368 g)	24 lbs

Bait spoons, measuring cups or other suitable implements may be used to measure and distribute bait. Maximum application rate per acre per baiting cycle is 24 lbs. of Flea Control Bait with Fipronil (0.0012 lb AI). Do not exceed 24 pounds of bait per acre (30 burrows) per baiting cycle.

Follow-Up Applications: Applications may be repeated one (1) month after the third application, following the same baiting cycle as listed above. Do not exceed 4 baiting cycles (or 12 applications) during the allowed 8-month treatment period (September 1 through April 30). Do not exceed a total of 96 lbs. of product per acre (0.0048 lbs. AI) during the allowed 8-month treatment period.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a cool, dry place inaccessible to children and pets. **Pesticide**

Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **Pesticide Disposal and Container Handling: {Plastic Buckets}** Non-refillable container; do not reuse or refill this container. Offer for recycling, if available, or reconditioning, if appropriate; otherwise, dispose of empty container in a sanitary landfill; or by incineration.

{Plastic Bags} Non-refillable container; do not reuse or refill this container. Completely empty bag then offer for recycling, if available; otherwise, dispose of empty bag in a sanitary landfill; or by incineration.
