The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. "To distribute or sell" is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.



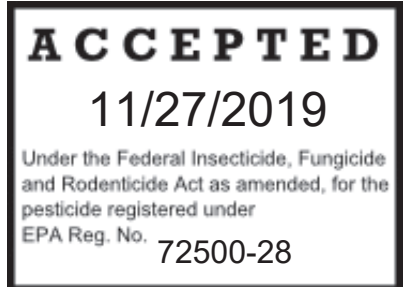

First Aid

DIRECTIONS FOR USE

Restricted Use Pesticide

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This label must be in the user's possession at the time of application of this product.

Apply this product only for the sites, pests and application methods specified on this label.

Read this Label:

Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets or other domestic animals to this product. To help prevent accidents:

1. Store product not in use in locations out of reach of children, pets and other animals.
2. Keep pets and livestock out of treated areas until bait has been consumed by the rodents.
3. Dispose of product container, unused, spoiled or unconsumed bait as directed on this label.

Use Restrictions: Use this product to kill flea populations on prairie dogs of the Genus *Cynomys* in parks, golf courses, non-crop rights-of-way and other non-crop areas. The insecticide in this product acts systemically to kill fleas (*Oropsylla spp.*) that commonly infest prairie dogs. Do not apply bait over roads, walkways or water.

Wear waterproof gloves when applying bait. With detergent and hot water, wash all utensils used for applying bait.

Do not use these utensils for mixing, holding or transferring foods or feeds.

Baiting: Scatter ½ cup (approx. 4 oz.) of bait on ground within 6 feet of each burrow opening used by prairie dogs. The openings of active burrows will generally be free of leaves, seeds, other debris or spiderwebs, and will show freshly turned earth, and have prairie dog feces nearby.

Bait spoons, measuring cups or other suitable implements may be used to measure and distribute bait. Maximum rate per baiting application per acre is 20 lbs. of Flea Control Bait with Fipronil (0.001 lbs. AI). 20 lbs. treat 80 burrows per acre.

Follow-Up Applications: Applications may be repeated every three months, using ½ cup of bait per active burrow. Do not exceed 4 baiting applications in a 12-months period. Do not exceed at total of 80 lbs. of product (0.004 lbs. AI) per acre in a 12-months period.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a cool, dry place inaccessible to children and pets. **Pesticide**

Disposal: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **Container Handling: {Plastic Buckets}** Non-refillable container; do not reuse or refill this container. Offer for recycling, if available, or reconditioning, if appropriate; otherwise, dispose of empty container in a sanitary landfill; or by incineration.

{Plastic Bags} Non-refillable container; do not reuse or refill this container. Completely empty bag then offer for recycling, if available; otherwise, dispose of empty bag in a sanitary landfill; or by incineration.
