Hazards to Humans and Domestic Animals

CAUTION: Harmful if swallowed. Causes moderate eye irritation. Avoid contact with eyes, skin and clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Keep away from children, domestic animals and pets.

Personal Protective Equipment (PPE): All handlers (including applicators) must wear long-sleeved shirt and long pants, socks and shoes and waterproof gloves. Any person who retrieves carcasses or unused bait following application of this product must wear waterproof gloves.

User Safety Requirements

Follow manufacturer's instructions for cleaning/maintaining PPE. IF no such instructions for washables exist, use detergent and hot water. Keep and wash PPE separately from other laundry. Remove PPE immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, thoroughly wash hands after applying bait and before eating, drinking, chewing gum, using tobacco or using the toilet, then change into clean clothing.

Environmental Hazards

This product is toxic to aquatic invertebrates, mammals and birds. Do not apply this product directly to water, or to areas where surface water is present or to intertidal areas below the mean high water mark. Do not contaminate water when disposing of equipment washwaters.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This label must be in the user's possession at the time of product application.

Apply this product only for the sites, pests and application methods specified on this label.

Use this product to control [kill] listed rats and mice and kill their blacklegged ticks (*Ixodes scapularis*). Blacklegged ticks may transmit Lyme disease.

Read this Label:

Read this entire label and follow all use directions and use precautions.

IMPORTANT: Do not expose children, pets or other non-target animals to rodenticides. To help prevent accidents:

- 1. Store product not in use in locations out of reach of children and pets.
- 2. Apply bait in locations out of reach of children, pets, domestic animals and non-target wildlife in tamper-resistant bait stations. These stations must be resistant to destruction by children under six years of age and dogs, and must be used in a manner that prevents such children from reaching into bait compartments and obtaining bait. If bait can be shaken from stations when they are lifted, units must be secured or otherwise immobilized. Even stronger bait stations are needed in areas open to hoofed livestock, raccoons, bears or other potentially destructive animals or in areas prone to vandalism.
- 3. Dispose of product container, as well as unused, spoiled and unconsumed bait, as specified on this label.

Bait stations are mandatory for outdoor, above-ground use. Tamper-resistant bait stations must be used if children, pets and non-target mammals, or birds may have access to bait.

Use Restrictions: This product may only be used to control [kill] the following listed rodents: Norway rats (*Rattus norvegicus*), Roof rats (*Rattus rattus*), House mice (*Mus musculus*), white-footed mice (*Peromyscus leucopus*), Cotton Rats* (*Sigmodon hispidus*), Eastern harvest mouse* (*Reithrodontomys humuli*), Golden mouse* (*Ochrotomys nuttalli*), Polynesian rat* (*Rattus exulans*), Meadow vole* (*Microtus pennsylvanicus*), White-throated woodrat* (*Neotoma albigula*), Southern plains woodrat* (*Neotoma micropus*), Mexican woodrat* (*Neotoma mexicana*) and kill blacklegged ticks that infest listed rodents in and within 100 feet of man-made structures constructed in a manner so

as to be vulnerable to commensal rodent invasions and/or to harboring or attracting rodent infestations. Examples of such structures include homes and other permanent or temporary residences, food processing facilities, industrial and commercial buildings, trash receptacles, agricultural and public buildings, transport vehicles (ships, trains, aircraft), docks and port or terminal buildings and related structures around and associated with these sites. Fence and perimeter baiting, beyond 100 feet from a structure as defined above, is prohibited. This product must not be applied directly to food or feed crops. Do not broadcast bait. Burrow baiting with this product is prohibited. Do not sell or distribute this product in individual containers holding less than 4 pounds of bait.

*Not permitted for use against these species in California.

Selection of Treatment Areas: Determine areas where listed rats, mice or meadow voles will most likely find and consume bait. Generally, these areas will be along walls, by gnawed openings, in corners and concealed places, between floors or walls, beside burrow openings and other locations where signs of rodents have been seen. Remove as much alternative food as possible.

Application Directions:

Rats: Apply 4 to 16 blocks per bait placement. Space placements at intervals of 15 to 30 feet in infested area. Maintain an uninterrupted supply of fresh bait for at least 10 days or until there no longer are signs of new feeding by rats.

Mice and Meadow voles*: Apply 1 bait block per placement. Space placements at intervals of 8 to 12 feet in infested area. At points of extremely high rodent activity use 2 bait blocks. Maintain an uninterrupted supply of fresh bait for at least 15 days or until fresh signs of feeding by mice and meadow voles cease to appear.

Follow-up (Rats, Mice, Meadow voles*): Immediately replace contaminated or spoiled bait. While wearing gloves, properly collect and dispose of all dead animals and leftover bait. To discourage reinfestation, limit sources of rodent food, water and harborage as much as possible. If reinfestation occurs, repeat treatment. Where a continuous source of infestation is present, establish permanent bait stations. Regularly check the stations and replace bait as needed.

Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage: Store in original container in a cool, dry place inaccessible to children and pets. **Pesticide Disposal:** Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **Container Handling:** Non-refillable container. Do not reuse or refill this container. Offer for recycling if available, or dispose of in trash or in a sanitary landfill or by incineration.


