- 1. (Step 1)Locate Mosquito Magnet® R-Octenol Biting Insect Attractant. Remove mosquito attractant cartridge from bag. Carefully peel back foil cover.
- 2. (Step 2) Locate the mosquito attractant carrier compartment inside the plume tube. Turn counter-clockwise about 1/8 turn. Remove end cap.
- 3. (Step 3) Place the open cartridge of mosquito attractant into the carrier compartment.
- 4. (Step 4) Replace end cap on carrier compartment. Be sure to align cap's "feet" with grooves inside carrier compartment. Secure cap by turning clockwise until it clicks (about 1/8 turn).

Replace cartridge every 30 days.* (Note: By day 30 of use the effectiveness of this product will have been diminished as most of the R-Octenol will have been released.)
