Flea & Tick Shampoo for Dogs and Cats, EPA Reg. No. 72586-1
Your Submission Dated August 28, 2009**

Dear Mr. Adams:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable with the following label revision provision(s):

General Comment:

1. Delete all text throughout the label marked with "~~strikethrough~~."

Optional Marketing Statements section comment(s):

2. Revise optional marketing statement #1 to read "For Dogs and Cats (Over 12 Weeks of Age)"

Directions for Use section comment(s):

3. To facilitate inclusion of language from the REDs for pyrethrins and piperonyl butoxide, add the following new subsection in its own text box immediately following the statement "It is a violation of Federal law ..." as follows:

GENERAL PRECAUTIONS & USE RESTRICTIONS

- Apply this product only as specified on this label.
- Do not contaminate of food or feedstuffs.
- Do not spray into pet's eyes, face or genitalia.
- Do not apply to (use on) pets less than 12 weeks old.
- Consult a veterinarian before applying this product on medicated, debilitated, aged, pregnant or nursing animals.
- Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

4. Revise the statement "**USE ONLY ON DOGS AND CATS**" to read "**USE ONLY ON DOGS AND CATS OVER 12 WEEKS OF AGE.**"

Storage and Disposal section comment(s): To facilitate inclusion of language from PR Notice 2007-4, incorporate the following changes:

- 5. Revise the subsection title "**Storage:**" to read "**Pesticide Storage:**"
- 6. Replace the "**Disposal:**" subsection with "**Container Disposal: If empty:** Non-refillable container. Do not reuse or refill this container. Offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain."

First Aid Statement section, HOT LINE NUMBER subsection comment(s):

- 7. Delete the 4 lines of text immediately following the section header.
- 8. Insert the following text as a 4th line in this section (table) as follows: "**HOT LINE NUMBER:** Have the product container or label with you when calling a poison control center, doctor, veterinarian or going for treatment. For additional information on this product (including health concerns, medical emergencies or pesticide incidents), you may call 1-877-315-9819."¹
- 9. Delete the 1st sentence immediately following this section (table), since it has been replaced by updated text added as part of Item #8.

Precautionary Statements section, ANIMALS subsection comment(s):

- 10. Delete this existing subsection in its entirety. This text will be placed within the new subsection added as part of Item #3 above.


Precautionary Statements section, HUMANS subsection comment(s):

- 11. Revise the 4th sentence in this subsection to read: "Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet."

A copy of your label stamped "Accepted with Comments" is enclosed for your records. Please submit two (2) copies of the final printed labeling, incorporating the above changes, before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with section 6(e) of FIFRA. Your release for shipment of the product bearing amended labeling constitutes accepting of these conditions.
