Dear Ms. Anastasiou:

The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable. This approval does not affect any conditions that were previously imposed on this registration. You continue to be subject to existing conditions on your registration and any deadlines connected with them.

A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling. You must submit one copy of the final printed labeling before you release the product for shipment with the new labeling. In accordance with 40 CFR 152.130(c), you may distribute or sell this product under the previously approved labeling for 18 months from the date of this letter. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. “To distribute or sell” is defined under FIFRA section 2(gg) and its implementing regulation at 40 CFR 152.3.

Should you wish to add/retain a reference to the company’s website on your label, then please be aware that the website becomes labeling under the Federal Insecticide Fungicide and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. In addition, regardless of whether a website is referenced on your product’s label, claims made on the website may not substantially differ from those claims approved through the registration process. Therefore, should the Agency find or if it is brought to our attention that a website contains false or misleading statements or claims substantially differing from the EPA approved registration, the website will be referred to the EPA’s Office of Enforcement and Compliance.

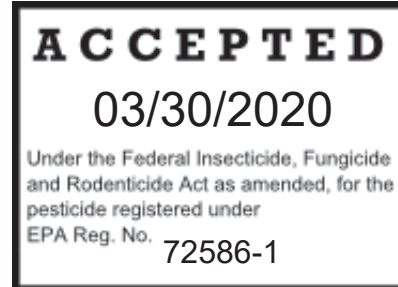

## DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

### USE RESTRICTIONS

- Apply this product only as specified on this label.
- Do not contaminate food or feedstuffs.
- Do not spray into pet's eyes, face or genitalia.
- Do not apply to (use on) pets less than 12 weeks old.
- Do not re-use any item that was used to apply the shampoo until it has been cleaned and sanitized.
- Except when applying directly to pets, do not apply this product in a way that will contact adults, children, or pets, either directly or through drift.
- Consult a veterinarian before applying this product on medicated, debilitated, aged, pregnant or nursing animals, including any prescription or non-prescription flea and tick medications.
- Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

### READ ENTIRE LABEL BEFORE EACH USE. USE ONLY ON DOGS AND CATS OVER 12 WEEKS OF AGE

Prior to using this shampoo on your pet, please perform a patch test to ensure your pet does not have any sensitivities to the pesticide used in this shampoo. Apply a small amount of shampoo on a small section of your pet's fur, allow the lather to penetrate the fur for five minutes before rinsing. Wait 48 hours and observe your pet for any allergic reaction.

Wet pet's coat thoroughly with warm water. Starting at the head and working back, work up a lather with this quick lathering formula, being sure that the lather is worked thoroughly into pet's coat down to skin. Allow lather to stand five minutes, then rinse completely with clean water and towel dry. Supervise pet during use and do not allow pet to lick coat while the shampoo is on. To maintain maximum effectiveness against both fleas and ticks, repeat (or reapply) every week.

### STORAGE AND DISPOSAL

**Pesticide Storage:** Keep this product in its tightly closed original container when not in use. Store in a cool, dry (preferably locked) area that is inaccessible to children and animals.

**Container Disposal: If empty:** Non-refillable container. Do not reuse or refill this container. Offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

### FIRST AID

**If swallowed**

- Call a poison control center or doctor immediately for treatment advice.
