On behalf of Elanco Animal Health, I am submitting for your review this notification to change the verbiage on the Elector® PSP Insect Control Agent label.

These changes are allowed per PRN 98-10, II B:

- 1. The pest being added is "house fly larvae," houseflies in this life stage are not considered a public health pest.
- 2. Elanco has and will maintain efficacy data against house fly larvae.
- 3. The pest matches the type of product registered insect/insecticide.
- 4. This pest occurs at sites already on the approved label.
- 5. The dosage, frequency, concentration or method of the application are not changed.
- 6. The addition of this pest to the label does not increase the exposure of the pesticide to humans or the environment.
- 7. House fly larvae are not subject to quarantine by USDA/APHIS.

This notification submission, in addition to this letter, includes:

- A fully executed Application for Pesticide Form [8570-1] containing the mandated certification statement.
- One copy of the current stamped approved label
- Two copies of the new draft label, one marked up to show the changes, and a clean one for PPIS.

MIXING FOR APPLICATIONS THAT REQUIRE DILUTION

This product is intended to be mixed with water and applied as a coarse or low-pressure spray. Fill the tank of the sprayer with water to about ½ of the total spray volume required. Start agitation and add the required amount of product. Continue mixing and agitation while filling the spray tank to the required spray volume. Maintain sufficient agitation during the application to ensure uniformity of the spray. Prepare spray fresh for each use.

GENERAL NOTICE

- This product may be applied as a general surface spray or a crack and crevice application.
 Applications may be made in and around poultry and livestock premises, including but not limited to poultry houses, beef and dairy barns, feedlots, stables, corrals and housing structures.
- This product may be used as a direct treatment to control Northern Fowl mites infesting poultry.
- Control is enhanced when interior and exterior perimeter applications are made in and around livestock and poultry structures. Normal sanitation practices of the structure consistent with good animal husbandry should be followed to enhance effectiveness of insect control agents.
- Lactating and non-lactating dairy and beef cattle, swine, sheep and poultry may be present at the time of premise treatment. Horses not intended for human consumption may also be present at the time of premise treatment.
- Cover or remove exposed feed and water from the area being treated.
- Do not use in milking rooms.
- Do not apply as a fog or space spray.

APPLICATIONS

TO CONTROL	APPLICATION
House flies (adults and larvae) Stable flies Little house flies	2 fl. oz. (60 mL) Elector PSP in 10 gallons of water will treat 5,000 – 10,000 ft². Use enough water in a directed spray to contact flies and their resting surfaces. Spray thoroughly, but do not allow run-off to occur.
Darkling beetles Hide beetles	 Use enough water to ensure thorough coverage of the area treated, especially litter, along feed and water lines, walls and support beams. Use a sprayer of appropriate design that is equipped to effectively apply low to moderate volumes of spray. Low volume spray: Up to 15 gallons of diluted spray applied to 20,000 ft². Moderate volume spray: Up to 40 gallons of diluted spray applied to 20,000 ft². 2 fl. oz. (60 mL) of product treats 5,000 ft² (8 fl. oz. of product treats 20,000 ft²). For severe infestations, 4 fl. oz. of product may be used to treat 5,000 ft² (16
Northern fowl mite (<i>Ornithonyssus</i> <i>sylviarum</i>)	 fl. oz. treats 20,000 ft²). Dilute 3 fl. oz. of product in 10 gallons of water. Apply 1 gallon of coarse spray per 100 birds under high pressure (no less than 100 – 125 psi), directed toward the vent area.

Egg Producing Poultry

Northern Fowl Mite: Re-application may occur every 14 days as needed. Spray birds in cages with a high pressure (100 – 125 psi) spray. Spray should be applied at the rate of 1 gallon per 100 birds. For optimum efficacy, direct spray toward vent area of chicken. Ensure adequate coverage.

Poultry Houses

House Flies (adults and larvae), Stable Flies and Little house flies: Treat areas where flies rest: pay attention to side walls, the ends of buildings, upper sides of posts, crossbeams, and manure. Spray in early morning when flies are resting. Use enough water in a directed spray to contact flies and their resting surfaces thoroughly, but do not allow run-off to occur. Do not contaminate feedstuffs, water or watering and feeding equipment with premise treatment. Re-application may occur every 7 to 10 days as needed, or when fly populations reach nuisance levels.

Darkling Beetles and Hide Beetles: Apply to floor area, especially to litter around feed and water lines and to walls and support beams, but do not allow run-off to occur. Application should also be made into cracks and crevices around insulation, and where pests have been seen or can find harborage. Reapply after each grow-out or sanitation procedure. Indoor control can be enhanced by making perimeter treatments to the outside of building foundations to prevent migrating adult beetles.

Livestock Housing

House Flies (adults and larvae), Stable Flies and Little house flies: Apply to vertical and overhead surfaces where flies may congregate. Feeders, waterers and feedcarts should be covered before application to prevent contamination. Do not contaminate feedstuffs or water with premise treatment. Pay attention to animal areas including fence railings, alleyways, manure, stanchions, pipes, window and doors, and other areas where flies congregate. Spray in early morning when flies are resting. Reapplication may occur every 7 to 10 days as needed, or when fly populations reach nuisance levels.

INTEGRATED PEST AND RESISTANCE MANAGEMENT

This product is a member of a unique class of insect control agents (spinosyns) with no pre-existing levels of resistance to any other insect control agents and can be rotated with all other classes, such as synthetic pyrethroids and organophosphates. House flies, stable flies, little house flies and other insects have demonstrated the ability to develop resistance to insect control products. Continual exposure of flies and other insects to a single class of insecticide may lead to the development of resistance to that class of insecticide. The following resistance management strategy will help ensure the prolonged usefulness of this product, as well as other conventional insecticides:

- Apply this product and other insect control agents only according to label directions
- Do not use less than the labeled rate of any insect control product
- Include multiple control tactics (cultural and/or biological controls) within an Integrated Pest Management Program
- Rotate this product with other classes of insecticides (synthetic pyrethroid, organophosphate) during a fly season

For advice concerning integrated pest management practices in relation to specific local conditions, consult resources in resistance management programs, your Cooperative Agricultural Extension Service, or your Elanco Animal Health representative (800-428-4441).

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Pesticide Storage:	Store in original container only, tightly closed in a secure place. Keep out of reach of children and domestic animals. In case of leak or spill, remove with absorbent materials and dispose of as waste.
Pesticide Disposal:	Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility
Container Handling:	Nonrefillable container. Do not reuse or refill this container. Offer for recycling, if available. Clean container promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank, drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then dispose of empty container in a sanitary landfill, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

- (1) Refund of purchase price paid by buyer or user for product bought, or
- (2) Replacement of amount of product used

In no case shall Elanco Animal Health be liable for consequential or incidental damages or losses.
