Under "Limitation of Remedies", add "*To the extent consistent with applicable laws*" to the beginning of the following paragraphs: "The exclusive remedy for losses or damages . . . etc." and "Elanco Animal Health shall not be liable for losses . . . etc"; and revise the sentence "In no case shall . . . damages or losses" to read "*To the extent consistent with applicable laws, Elanco Animal Health shall not be liable . . . damages or losses*".
- 2. Submit a revised data matrix citing appropriate data for the acute dermal toxicity and dermal sensitization requirements (See enclosed Agency's product toxicity review dated June 9, 2008).
- 3. Submit to the Agency, data on one year storage stability testing (830.6317), conducted concurrently with the corrosion characteristics study (830-6320) at 0, 3, 6, 9 and 12 months of warehouse storage.

If you fail to satisfy any of the conditions imposed on this registration, the Agency may issue notice to cancel this product.
