### FIRST AID



### Technical Information Bulletin

#### Summary

PROXEL® BZ preservative, an aqueous dispersion of a synergistic blend of 1-2-benzisothiazolin-3-one and zinc 2-pyridinethiol-1-oxide, is an antibacterial/antifungal preservative for aqueous compositions such as latex emulsions, paints, water based adhesives, aqueous slurries such as titanium dioxide and clay, and tape joint compounds

Proxel BZ is registered with the Environmental Protection Agency and has been granted EPA registration No. 72674-14.

#### General


Many aqueous industrial compositions can support the growth of a wide range of bacteria and fungi. These organisms can chemically destroy the components of these formulations and render them unusable. High solids formulations are especially prone to fungal contamination and cannot be suitably controlled by bactericides. Proxel BZ preservative is effective against both types of microbes and will prevent growth of even high concentrations of fungal organisms.

PROXEL BZ is an effective preservative against growth of bacteria and fungi in the aqueous systems indicated and exhibits:

- Effective control of a wide range of bacterial and fungal organisms at economic concentrations.
- Long-term storage stability.
- Ease of use due to its liquid form and excellent compatibility in most aqueous systems.

**Directions for Use**

PROXEL BZ is an effective preservative in most aqueous compositions. Typical applications, and the suggested range of concentrations on which trials can be based, are:

**General Recommendations**

The concentration required to give protection depends on several factors. These include the susceptibility of the system to microbiological degradation, the extent to which microorganisms can gain access, the species involved, pH, temperature, and length of time for which protection is required.

For protection against bacterial and fungal attack, a concentration within the range of 0.025-0.40% PROXEL BZ is almost invariably sufficient.

Corrosive, causes eye damage. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. May cause allergic skin reaction. **First Aid:**


If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

If Swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a poison control center or doctor. Do not give anything by mouth to an unconscious person.

**Note to Physician:** Possible mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.



**Environmental Hazards**
