DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Pool Breeze Algicide 60 is used to control the growth of algae in swimming pools. For maximum effectiveness, pools containing heavy growth of algae should be cleaned prior to using Pool Breaze Algicide 60.

For pools having just visible algae growth, add aid initial dose of 11 to 17 fluid ounces of Pool Breeze Algicide 60 per 10,000 gallons of water and remove settled algae. For treatment of freshly cleaned and filled gools, add 6 to 11 fluid ounces of Pool Breeze Algicide 60 per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of Pool Breeze Algicide 60 per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance

Pool Breeze Algicide 60 will prevent growth of most algae during the off-season winter months when pools are not in use.
