

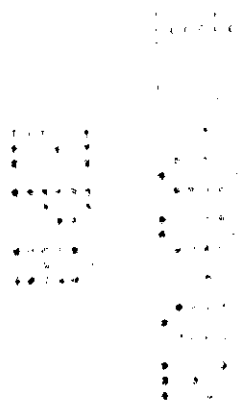

**DIRECTIONS FOR USE**

In accordance with Federal law to use this product in a manner inconsistent with its labeling. Pool Breeze Advantage Algicide is used to control the growth of algae in swimming pools. For maximum effectiveness, pools containing heavy growth of algae should be cleaned prior to using Pool Breeze Advantage Algicide.

For pools having just visible algae growth, add an initial dose of 11 to 17 fluid ounces of Pool Breeze Advantage Algicide per 10,000 gallons of water and remove settled algae. For treatment of freshly cleaned and filled pools, add 6 to 11 fluid ounces of Pool Breeze Advantage Algicide per 10,000 gallons of water. Subsequent additions of 2 to 4 fluid ounces of Pool Breeze Advantage Algicide per 10,000 gallons of water should be made every 5 to 7 days after initial treatment for maintenance.

Pool Breeze Advantage Algicide will prevent growth of most algae during the off-season winter months when pools are not in use. For pools which have been properly treated during the swimming season and are free of visible algae, add 6 to 10 fluid ounces of Pool Breeze Advantage Algicide per 10,000 gallons of water. 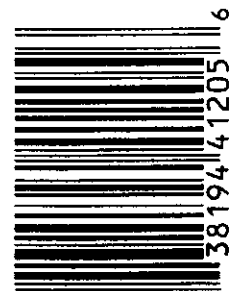
