### FOR INITIAL APPLICATION IN POOLS SANITIZED WITH BRILLIANCE<sup>TM</sup> FOR PCOLS OR POOL BREEZE<sup>®</sup> PRODUCTS:

Backwash and clean fitter. Balance your pool water and adjust pH between 7.2 - 7.6. Add 2 lbs. of ENDURE per 1,000 gallons of pool water by broadcashing the product over the surface of the pool with the pump running. This initial treatment should be added in three doses with one third of the required amount being added each application. Brush any undissolved product from the bottom of the pool. The pH of the pool water will rise as a normal reaction to the introduction of ENDURE. One hour after each application, adjust the pH to 7.2 - 7.6 with pH decreaser, according to label directions. Allow at least 8 hours between the applications of ENDURE. Do not add additional product until the pH is between 7.2 - 7.6 (NOTE: For every 2 pounds of ENDURE, approximately 1 pound of pH decreaser will be required for pH adjustment). The pH of the pool water will rise as a normal reaction to the introduction of this product therefore, one hour after each application, adjust the pH to 7.2 - 7.6with pH decreaser, according to label directions. ### FOR MAINTENANCE APPLICATION:

This product is stable in pool water and not degraded by sunlight. The primary loss of product is through splash-out, backwashing and dilution from heavy rains. Therefore, once the initial application is made, minor and infrequent additions would be all that is required unless a substantial amount of water is drained from the pool.

### STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage or disposal. Keep this product dry in original tightly closed container until use. Store in a cool, dry, well ventilated area away from heat or open llame. Do not reuse container, but place in trash collection, Rinse thoroughly before discarding in trash. Do not store where children or animals may gain access.
