

Precautionary Statements

Hazards to Humans and Domestic Animals

If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or you Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

Directions for Use

It is a violation of Federal Law to use this pesticide in a manner inconsistent with its labeling.

- Wear gloves and eye protection when handling infectious waste.
- SaniSorbX is a dissolvable pouch.
- Insert the SanisorbX pouches through the port of the suction canister. See table below for applicable number of pouches depending on size of suction canister
- SanisorbX is effective for suction canister contents up to 30% blood serum.
- Recap port and allow 30 minutes for solidification before handling.
- Dispose of treated medical waste in compliance with local, state, and federal regulations.
- If pouch opening and solidification does not occur, handle as untreated medical waste following local, state, and federal regulations.
