# **DIRECTIONS FOR SPECIFIC USES**

# Storage Containers (Garment bags, closets, drawers, lockers, etc.):

Tear open the packaging pouch prior to use and remove the (1)(5)(10)(25)(50) gram deodorizing pouch. Place the deodorizing pouch inside the container, not directly on clothing. Each pouch will treat (2)(10)(25)(50)(100) ft<sup>3</sup> space for up to 1 month.

### Refrigerators:

Tear open the packaging pouch prior to use and remove the (5)(10)(25) gram deodorizing pouch. Place the deodorizing pouch in the upper part of the refrigerator. Each pouch will treat up to 1 month. This product can only be used in commercial (non-residential) refrigerators that do not store food products.

## Waste Containers (Trash cans, trash bags, etc.):

Tear open the packaging pouch prior to use and remove the (1)(5)(10)(25) gram deodorizing pouch. Place the deodorizing pouch inside the waste container. Each pouch will treat up to 1 month.

## Refuse Containers (Dumpsters)

Tear open the packaging pouch prior to use and remove the (50)(100)(200) gram deodorizing pouch. Place the deodorizing pouch in the refuse container. Each 50-gram pouch will treat 160 ft<sup>3</sup> container capacity for up to 1 months

### Automobiles:

Tear open the packaging pouch prior to use and remove the (5)(10) gram deodorizing pouch. Place the deodorizing pouch in a designated holder, and hang it on the mirror or the clothes hanger. Close all the doors and vents of the automobile and wait for 30 minutes. After 30 minutes, open all the doors of the automobile, and wait for at least 5 minutes before reentering the automobile. No passenger should be present in the automobile throughout the deodorizing process.

### **Boat Cabins:**

Tear open the packaging pouch prior to use and remove the (10)(25)(50) gram deodorizing pouch. Place the deodorizing pouch in the boat's cabin where odors are most intense. Each pouch will treat (100)(250)(500) ft<sup>3</sup> of cabin space for up to 1 month.

#### Basements:

Tear open the packaging pouch prior to use and remove the (10)(25)(50) gram deodorizing pouch. Place the deodorizing pouch in the basement where odors are most intense. Each pouch will treat (100)(250)(500) ft<sup>3</sup> of space for up to 1 month.

### Portable Restrooms:

Tear open the packaging pouch prior to use and remove the (10)(25)(50) gram deodorizing pouch. Place the deodorizing pouch in the portable restrooms. Each 25 gram deodorizing pouch will treat a 80 ft<sup>3</sup> portable restroom for up to 1 month.

### Garbage Trucks:

Tear open the packaging pouch prior to use and remove the (100)(200) gram deodorizing pouch. Place one to two deodorizing pouches in the garbage truck. Each pouch will treat 500-900 ft<sup>3</sup> body capacity for up to 1 month.

### Litter Box and Pet Area

Tear open the packaging pouch prior to use and remove the (5)(10)(25) gram deodorizing pouch. Place the pouch directly above the litter box area. Each pouch will treat up to (30)(60)(150) ft<sup>2</sup> area for up to 1 month.
