Hold card in upright position. Point tip of tube up and away from user's face and body, then cut along the dotted line, using the cc marks on the body of the applicator as a guide apply the SBP-2001 as follows by firmly squeezing the applicator:

- 1] streak 1 cc on top of the croup.
- 2] streak 1 cc on the forehead under the forelock; take care to keep away from eyes and mucous membranes.
- 3] spot 1 cc over the dorsum of the carpus [2 cc total]
- 4] spot 1 cc over the plantar surface of the tarsus [2 cc in total]

Place empty applicator in trash

Do not reapply for 14 days.
