

- 2] streak 0.5 cc on each side of the withers [1 cc total]
- 2] streak 1 cc on each side of the hind quarters [2 cc total]
- 3] spot 1 cc to the back of each front leg below the elbow [2 cc total]
- 4] spot 1 cc above each hock, on the gaskin muscle [2 cc total]

Place empty applicator in trash

Do not reapply for 14 days.
