- c. Revise the precautionary statement to read as follows:
- “Harmful if swallowed, absorbed through skin. Avoid contact with skin, eyes or clothing. Avoid breathing dust. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash clothing before reuse.”
- d. Delete the Keep Out of Reach of Children (KOROC) statement from the pesticide storage instructions. Note the correct spelling for “Out” in the KOROC statement.
- e. The Storage and Disposal must be revised to read as follows:

STORAGE AND DISPOSAL
Do not contaminate water, food or feed by storage or disposal.

"PESTICIDE STORAGE: Keep away from food, drink and animal feeding stuffs. Keep in a dry place (max. 60% relative humidity) between 0 and 30° C.



- do not change vase water; solution will be effective for the life of the flowers
- top up with solution
