Storage: Store in a cool, dark, frost-free place in the original tightly closed container away from children and pets.

Obtain a 55 gallon open top drum and insert a drain spigot about 12 inches up from the bottom of the upright drum. Use this container exclusively for neutralization of unwanted SILGARD Technical RS-System Activator solution.
 Put the unwanted SILGARD Technical RS-System Activator solution into the drum. When the drum is approximately two thirds full of spent solution, slowly pour in 2 quarts of hydrogen peroxide solution. Stir the drum contents and let stand for 24 hours. A gray-black deposit will form at the bottom of the drum.

- 3. Drain off water above the drain level. Contact federal, state or local authorities to obtain license for disposal of this water.
- 4. Do not drain off the remainder of the water and silt. It must be sent to an industrial waste facility.

Container Disposal: Completely empty container. Then dispose of empty container in a sanitary landfill.
