Dear Dr. Bade:

The amendment referred to above submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) section 3(c)(5), is acceptable provided that you:

- 1) Submit and/or cite all data required for registration/reregistration of your product under FIFRA section 3(c)(5) when the Agency requires all registrants of similar products to submit such data.
- 2) Submit two (2) copies of your final printed labeling before you release the product for shipment. Final printed labeling means the label or labeling of the product when distributed or sold. Clearly legible reproductions or photo reductions will be accepted for unusual labels, such as those silk-screened directly onto glass or metal containers or large bags or drum labels.

Moreover, as this supplemental labeling was requested on your initiative and is based upon a previously accepted label amendment dated November 27, 2012, within 18 months of the date of this letter, such supplemental labeling must be integrated into the label affixed to product that is distributed or sold (40 CFR § 152.130(c)). You must also note that adding the supplemental labeling to an already produced product (whether by affixing the supplemental label to the container or by causing the label to accompany the product) is considered production and must be done in a registered establishment. Handing out supplemental labeling at a dealership, unless it is a registered establishment, is not acceptable.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for ship RONG WIP BO duct bearing the amended labeling symbol phstitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

CROP	OBJECTIVE / BENEFIT	APPLICATION TIMING / USE INSTRUCTIONS
Apple	To increase fruit set.	Apply one pouch of <i>ReTain</i> per acre, as a single application from pink stage to full bloom. Applications made prior to pink stage or after full bloom will significantly reduce efficacy of the treatment. Do not apply after petal fall.
Cherry	To increase fruit set.	Apply one pouch of <i>ReTain</i> per acre, as a single application during bloom. Applications between balloon stage to first bloom are more effective than earlier or later applications. Do not apply after petal fall.
European Pear cultivars	To increase fruit set.	Apply one pouch of <i>ReTain</i> per acre, as a single application from white bud stage to full bloom. Applications made prior to white bud stage or after full bloom will significantly reduce efficacy of the treatment. Do not apply after petal fall.

IMPORTANT:

- For apple and pear, do not apply more than one pouch for increasing fruit set. Do not use more than one pouch for harvest management and improvement of fruit quality. Do not apply more than 2 pouches of *ReTain* per acre per year.
- For sweet cherry, do not apply more than one pouch for increasing fruit set. Do not apply ReTein.to sweet cherry trees when fruit are present.

Water Volume: *ReTain* efficacy requires that flower buds and flowers receive thorough spray coverage. To ensure thorough coverage use calibrated spray equipment (i.e. air blast sprayer) and adjust water volumes based on tree size and spacing. Use sufficient water volume to achieve thorough coverage without excessive runoff. In most cases, a spray volume of 100 to 200 gallons per acre has been shown to be effective.

Use of Adjuvants: Use of adjuvants with *ReTain* for bloom applications has not been fully researched. Some adjuvants will cause a bloom thinning effect and will reduce the benefits of *ReTain*.
