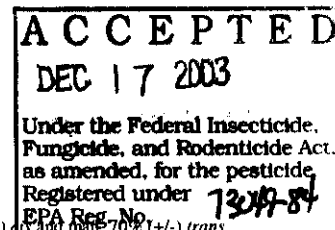

#### CAUTION

***Wasps, Hornets, Yellow Jackets, and Bees*:** Make applications in late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible.
