Dear Dr. Sharp,

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable subject to the comments listed below. Five copies of the finished labeling must be submitted prior to releasing the product for shipment.

1. Place a foot note below the active ingredient statement that qualifies the active ingredient Resmethrin as follows: "Cis/Trans isomers ratio: max 30%(±) cis and min. 70%(±) trans."
2. Within the Physical and Chemical Hazards section, revise the statement "Do not use on electrical equipment or on surfaces that can be harmed or stained by water." to "Do not apply this product around electrical equipment due to the possibility of shock hazard." In addition, the statement within the same sentence "...or use on surfaces that can be harmed or stained by water." must be moved to the Directions for Use. Directly below the "SHAKE WELL BEFORE USING". You may use "Do not use this product on surfaces that can be harmed or stained by water."

DIRECTIONS FOR USE

While spraying for flying insects outdoors, hold container 4 to 6 feet away from plants and shrubs. Direct spray to fill the air around these plants without heavily wetting the plant foliage.

Spray outdoor areas of the yard, patio and campground when there is no breeze or spray in the direction of a slight breeze. Control flies, mosquitoes and gnats up to 21 feet away using this fog nozzle.

SHAKE WELL BEFORE USING

Shake well before using. Point spray nozzle away from face and in the direction of the space to be treated. Press down valve button and allow spray fog to fill the air where flying pests linger. For larger areas, best results are obtained by spraying in the direction of a slight breeze that allows the fog to drift into the areas of infestation. Spray while moving away from treated areas. Allow spray to dissipate before occupying the treated area.

FLYING INSECTS: Reduce annoyance from *Flies, Mosquitoes, Moths and Gnats* by directing spray from a distance of 4 to 6 feet away from flowering plants, shrubbery, and grass to where the insects may be resting. Avoid heavy wetting of plant foliage. Also spray around garbage cans and other breeding areas. Spray directly on *Wasps* and *Hornets*. Thoroughly wet the nesting area during the evening when these insects are least active.

CRAWLING INSECTS: Spray directly on *Ants, Centipedes, Sowbugs, and Spiders*. Treat areas around garbage cans, picnic sites and camp grounds infested by these pests. Also thoroughly spray ant hills for best results. Spray in short bursts of 2 seconds at a 4 to 6 foot distance for control of Brown Recluse Spider and Black Widow Spider.
