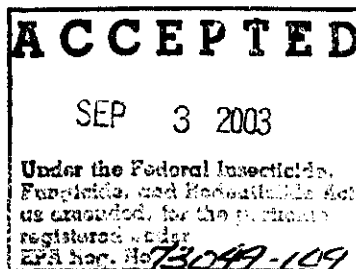

DIRECTIONS FOR USE

Shake well before each use. Remove protective cap. Aim spray opening away from person. Push button to spray.

DOUBLE ACTION INSECT KILLER: This is a dual purpose formulation that can be used as a contact spray against wasps and crawling insects and as a residual insecticide providing up to 4 weeks control of roaches.

Do not use on edible crops. Do not use in edible product areas of food processing plants, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed.

FOR INDOOR USE: Can be used in home kitchens, and non-food areas of food handling establishments, commercial, industrial, office, residential, public, institutional and storage buildings, homes, hotels, ship cabins and hospitals. In hospitals, remove patients prior to treatment of the surrounding area. Ventilate two hours prior to returning patients. Also for use in buses, automobiles, and non-food areas of trucks, boxcars and ship cargo holds. Also for use in dog kennels and horse stables. In horse stable, not for application if horses will be used for food.

TO KILL *Roaches, Earwigs, Grain Mites, Sowbugs, Scorpions, Spiders, and Centipedes:* Contact spray: Spray thoroughly into hiding places such as cracks, crevices, moist areas, openings around pipes and sinks, under refrigerators, baseboards, and storage areas. Spray directly on insects where possible.

Residual Spray: Spray baseboards, cracks, crevices, around door and window frames, and other hiding places in cracks and crevices, lower walls, dark places. Spray at the rate of 3 to 4 seconds per linear foot at a distance of 12 to 14 inches from the surface.

TO KILL *Spiders and Scorpions:* Direct short burst of spray on spiders and scorpions.

TO KILL *Wasps:* Make applications in the late evening when insects are at rest. Spray liberally into hiding and breeding places, contacting as many insects as possible.

TO KILL *Ants:* Apply to ant trails and around doorsills, window frames and other places where ants may enter.

TO KILL *Tent Caterpillars:* Make applications when caterpillars are young and tents are first noticed. For best results, apply late in the evening when caterpillars have returned to their tents. Aim spray directly at tents, and totally saturate on all sides.
