## PRECAUTIONARY STATEMENTS Hazards to Humans and Domestic Animals

#### CAUTION

#### **Environmental Hazards**

This product is toxic to fish and aquatic invertebrates. Do not apply directly to water or to areas where surface water is present or to intertidal areas below the mean water mark. Do not apply when weather conditions favor drift from treated areas. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Do not contaminate water when disposing of equipment wash waters. This product is highly toxic to bees exposed to direct treatment or residues on blooming crops or weeds. #### **DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

UltraTec DS 205 works in two ways:

- 1) it kills bugs fast on contact; and
- 2) its residual action keeps on killing *Argentine Ants, German Cockroaches* and *Houseflies* for up to 12 weeks (3 months) after you spray. Contact kill gives you immediate results when spraying insects directly.

#### Use Restrictions:

- Do not allow adults, children, or pets to enter the treated area until sprays have dried.
- Do not apply this product in a way that will contact adults, children or pets, either directly or through drift.
- Do not apply in schools, daycares, or other locations where children are present.
- Surface spray uses are limited to spot treatments only. Broadcast surface applications are prohibited.
- Spray until surface is slightly wet but not to the point of run-off. Over application may cause damage.
- Remove pets, birds and cover fish aquariums before spraying.
- Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Exposed food should be covered or removed.
- Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

Outdoor Application Restrictions:

- Outdoor uses are limited to spot treatment only. Broadcast applications are prohibited.
- Do not water the treated area to the point of run-off
- Do not make applications during rain.

UltraTec DS 205 insecticide is intended for use in and around residential structures and their immediate surroundings. Permitted areas of use include: apartments, atriums, attics, automobiles, basements, bathrooms, boats, cabins, campers, carports, cat sleeping quarters, clothes storage, condominiums, decks, dens, driveways, garages, gazebos, homes, kitchens, lanais, living rooms, parlors, patios, pet sleeping areas, play rooms, porches, recreational vehicles, rooms, solariums, storage areas, sun rooms, utility rooms and verandas.

#### INDOORS:

To kill American and German Cockroaches (Including Adult and Immature Stages of Both Non-Resistant and Organophosphate and Carbamate Resistant Strains), Ants including Argentine, Carpenter, Red Imported Fire Ant, Harvester and Pharaoh, Asian Lady Bird Beetles also known as Lady Bugs, Hobo, Black Widow and Brown Recluse Spiders, Booklice, Boxelder Bugs, Centipedes, Crickets, Dermestids, Firebrats, Fleas, Palmetto Bugs, Silverfish, Sowbugs, Ticks and Waterbugs: Apply as a spot and crack & crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. When pests are driven out, spray directly. Repeat as necessary but not more than once per week.

[Roaches: Spray in cracks and crevices, around baseboards and other hiding places until wet. When driven out, spray bugs directly.]

To kill Ants including Argentine, Pharaoh, Harvester, Carpenter and Fire Ants: Spray ant trails and around doors and windows and other places where ants enter the house. Repeat as necessary but not more than once per week.

Carpenter Ants: For effective control, locate and treat nests and surrounding areas. Apply around doors and windows and other places where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings.

Ticks and Fleas ON SURFACES: Remove pet bedding and destroy or clean thoroughly. Spray pet resting quarters. Adult fleas and larvae contacted by spray will be killed. Put fresh bedding down once spray has dried. Do not spray animals directly. For best results, pets should be treated with an appropriate flea and/or tick control product registered for use on pets before allowing them to return to the treated area. Spray rugs and carpets where infestations are bad. Delicate fabrics should be tested for staining in an inconspicuous area prior to use.

**Black Widow, Brown Recluse and Hobo** *Spiders*: Apply along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl or hide. If spiders are flushed out, spray insect directly for best results.

Asian Lady Bird Beetles also know as Lady bugs: spray areas where bugs crawl or are resting.

Centipedes, Ground Beetles, Pillbugs, Sowbugs, Scorpions and Ticks: Apply around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

[Silverfish, Crickets, Spiders, Earwigs: Apply around doors and windows, baseboards, storage areas, pipes and other areas infested by these pests or spray pests directly. Spray surfaces until wet.]

PANTRY PESTS: Grain Beetles (Rusty, Merchant and Saw-Toothed), Flour Beetles (Red and Confused), Chocolate Moths, Cigarette Beetles, Clover Mites, Cluster Flies, Drugstore Beetles, Elmleaf Beetles, Rice Weevils, Lesser Grain Borers, Spider Beetles and Tobacco Moths: Treat exposed stages. Remove all food-stuffs, utensils and shelf paper from area to be treated. Discard used shelf paper and any infested foodstuffs. Apply spray to shelves and in cracks and crevices behind and under cupboards and cabinets. Allow spray to dry prior to replacement of shelf paper, food and utensils. Wash any exposed food handling surfaces and utensils before use.

Carpet Beetles (Black, Furniture and Varied): Spray on and under edges of floor coverings, under rugs and furniture and in closets or other localities where these insects are found.

**Webbing Clothes Moths**: Use this product as a crack and crevice treatment in closets and other storage areas where these pests are found. This is an adjunct treatment and will not control moth larvae already on clothes. Do not apply to clothing.

#### **OUTDOORS:**

Do not use on edible crops.

Point nozzle away from face. Hold can on a slight downward angle, approximately 12 - 18 inches from surface to be sprayed. For best results, spray when air is calm. Spray with wind if breeze is blowing.

PESTS ON OUTSIDE SURFACES OF BUILDINGS: For control of building infestation of Ants (including Argentine, carpenter, pharaoh, harvester and red imported fire ants), Asian lady bird beetles, spiders (including Black Widow, Brown Recluse and Hobo spiders), Clover Mites, Crickets and Sowbugs (Pillbugs Apply as a residual spot and crack & crevice treatment where insects are active and tend to congregate. Test spray a small area first to check for staining. Spray areas include foundations, screens, window frames, eaves, porches, patios, garages and refuse dumps. Repeat treatment as necessary, but not more than once per week.

CRAWLING INSECTS: Ants, Cockroaches (Including Asian Cockroaches), Centipedes, Crickets, Mole Crickets, Waterbug, Spiders including Black Widow, Brown Recluse and Hobo, Asian Lady Bird Beetles and Silverfish. Hold can 12 to 18 inches from surface to be treated and spray infested surface of patio or picnic area, hitting as many insects as possible. Apply as a spot and crack & crevice spray to slightly moisten the surface. Also spray legs of tables and chairs to repel ants. Spray ant hills for best control.

Ants: Spray around ant trails and hills. Spray around nests hidden under steps, brickwork, concrete, etc. Break apart accessible nests and spray on and around debris until surface is slightly wet. Repeat as necessary but not more than once per week. This product should not be used to treat fire ant mounds.

[Ants (including Carpenter and Argentine ants): Spray ant trails and hills. If nest can be located, spray surface of nest until wet.]

Lone Star Ticks, Dog Ticks, Crickets, Fleas and Earwigs: Apply as a spot treatment to infestation in bushes, grass or weeds.

Wasps, Hornets and Bees: Spray nests and bees directly. Aim spray at nest openings, spray for 2-3 seconds. Applications should be made late in the evening when insects are at rest. Outdoor spot treatments or limited occupancy areas (i.e. attics, barns, storage sheds) only.

FLYING INSECTS: Houseflies, Gnats, Mosquitoes and Small Flying Moths: Use only on outdoor surfaces. Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray localized resting areas, such as under eaves, porches, surfaces around light fixtures and cords, railings, etc. where these insects may rest. Insects coming to rest on treated surfaces will be killed.

FOR THE CONTROL OF ORNAMENTAL GARDEN INSECTS: For use on roses, dahlias, asters and other ornamentals to kill *Japanese Beetles* hit by spray, as well as *Whiteflies, Aphids, Armyworms, Lace Bugs, Mealy Bugs, Exposed Thrips, Pavement Ants, Spiders, Spider* and *Red Mites, Clover Mites* and *Leafminers*.

May be used on plants, as well as a multi-purpose spray in small ornamental gardens and for spot treatments of incipient insect infestations to prevent spreading in large garden areas.
