Dear Mr. Assaf:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable with the following provision(s):

General Statement:

1. Delete all text throughout the label marked with "strikethrough."

Ingredient Statement comment(s):

- 2. Revise the ingredient listed as "Piperonyl Butoxide*" to read: "Piperonyl Butoxide: Technical*"
- 3. Revise the footnote on the label for piperonyl butoxide as follows: "*Equivalent to 16.0% of (butylcarbityl)(6-propylpiperonyl) ether and 4.0% of related compounds."

First Aid Statement section comment(s):

4. Replace the 2nd sentence from the next-to-last statement in this section with: "For additional information on this product (including health concerns, medical emergencies or pesticide incidents), you may call 1-877-315-9819."¹

Storage and Disposal Statement section, Container Disposal subsection comment(s):

5. Insert the statement "Then offer for recycling or reconditioning or puncture and dispose of in a sanitary landfill or by other procedures approved by state and local authorities." immediately following the word "emptying" at the end of this subsection.

Valent BioSciences Corporation should note that a notice of availability of EPA's reregistration eligibility decision (RED) document for products containing pyrethrins was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389). In addition, EPA's RED for products containing piperonyl butoxide was published in the *Federal Register* on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386). As a result, additional data and/or labeling changes may be required for products containing pyrethrins and piperonyl butoxide.
