Spray pet sleeping quarters, bed, entire floor and floor covering, and pay special attention to cracks and crevices, around baseboards, and window and door frames. Infested upholstered furniture may also be treated with this product. When treating surfaces and fabrics where water alone could stain, spray in an inconspicuous area to test for possible staining or discoloration.
