Dear Ms. Sharp:


The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments listed below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Reinstate the "If Inhaled" first aid statement and corresponding language under Precautionary Statements. The results of the acute inhalation study indicate it is Toxicity Category III.
2. The results of the primary skin irritation study indicate it is in Toxicity Category III. Therefore **replace** "Causes skin irritation. Do not get on skin or clothing. " **with** "Avoid contact with skin or clothing".
3. Replace "Prevent re-entry of dogs & cats into treated area until spray deposits are dry" with "Do not allow children or pets to contact treated areas until surfaces are dry."
4. Under Directions for Use add "Do not use in commercial food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared, processed, served or stored."

5. Move the statements beginning "Avoid contamination of feed and food stuffs ....." and ending "..... until surfaces are dry.", to the Directions for Use section.
6. Add the following precaution to the first paragraph under Outdoors "Remove all exposed food and cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops.

#### SHAKE WELL BEFORE USING

Remove protective cap, hold container upright and spray from a distance of 12 to 15 inches. Remove birds and cover fish aquariums before spraying.

#### INDOORS:

**Houseflies, Fruit Flies, Mosquitoes, Gnats, Wasps, Hornets, Bees, Black Flies, Skipper Flies, Blow Flies and Small Flying Moths:** Close all doors and windows and direct spray upward into center of room with a slow sweeping motion. Spray 5-10 seconds for average room. Direct spray to all parts of the room, especially windows and other light sources which attract these insects. Keep nozzle in constant motion. Keep room closed for 15 minutes after spraying. Ventilate room thoroughly before re-entry. Sweep up and discard fallen insects.

#### OUTDOORS:

Point spray nozzle away from face. Hold can on slight downward angle. For best results, spray when air is calm. Allow a few minutes for product to take effect. Spray with wind if breeze is blowing.

**Flying Insects: Flies, Mosquitoes, Gnats, Small Flying Moths, Hornets and Yellow Jackets.** Allow fog to drift over area. Direct spray toward bushes, or grass from at least 4 to 6 feet away. Give special attention to breeding areas such as garbage cans and compost piles.

### STORAGE AND DISPOSAL

**Storage:** Store in a cool, dry area. Do not transport or store below 32°F.

**Disposal:** Do Not Puncture or Incinerate!
