Dear Dr. Sharp:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments below. Two copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

- 1. Revise the "Hazards to Humans & Domestic Animals" section to read as follows:
  - "CAUTION. Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum or using tobacco." [NOTE: This labeling is based on the product's classification as a category III eye irritant.]
- 2. In "Step 2: ACTIVATION OF FOGGER" under "How to Use", delete the sentence "Do not place can within 6 feet of pilot lights", since it conflicts with the requirement to turn off all pilot lights and could potentially confuse consumers.
- 3. In the "Disclaimer of Warranties", delete the word "whatsoever" from the statement regarding "special, incidental or consequential damages." The revised statement should read "Valent BioSciences Corporation disclaims any liability for special, incidental or consequential damages resulting from the use or handling of this product.

After activation, leave room or house at once. Keep area closed for 2 hours before airing out. Open all doors and windows and allow to air for 30 committees. Repeat spraying in two weeks if necessary.
