Mix as needed; do not store diluted material.

PREMISES SPRAY: Spray directly to walls and ceiling as residual surface treatment only. Do not treat manure or litter. Avoid contamination of feed and water. Do not apply directly to livestock or poultry.

Shake well before measuring.

*1 oz. of this powder equals 5 level tablespoons. Shake canister before measuring. Make up only as required.

Re-treat as necessary, but not more often than once every 2 weeks. The use of any residual fly spray should be supplemental with proper manure management and general sanitation to reduce or eliminate fly breeding site.
