NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Our records have been updated to reflect the new primary brand name, "Pyraperm 7-14-35 Concentrate." The previous primary brand name, "Pyraperm 7-14-35 WB Concentrate," is no longer valid. 
