The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable subject to the comments below. Two (2) copies of the finished labeling must be submitted prior to releasing the product for shipment. A stamped copy of the label is enclosed for your records.

1. Add footnotes to the ingredient statement as on the previously accepted label:
 - a. The footnote for Piperonyl Butoxide should read: "Equivalent to min 16% (butylcarbityl)(6-propylpiperonyl) ether and 4% related compounds." This is consistent with the active ingredient designation on the piperonyl butoxide source product label.
 - b. You must retain the footnote to the Inert Ingredients: "Contains petroleum distillate."
