The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, is acceptable subject to the comments listed below.

- 1) In your letter date September 22, 2002, you agreed to make the following changes:
 - a) Add "For Residential Use Only" so the product would not be subject to "Worker Protection Standards. Please change statement to "Use in the Gardens Only" instead of "Residential Use Only".
 - b) Delete the statement "when other insecticides are prohibited due to residue restrictions and use limitations
- 2) Remove the statement "Leaves no Objectionable Residues."
- 3) The Confidential Statement of Formula as amended, is acceptable. A copy is placed in the file as a matter of record.

Enclosed is a copy of your label stamped "Accepted with Comments". Submit four (4) copies of the final printed labeling.

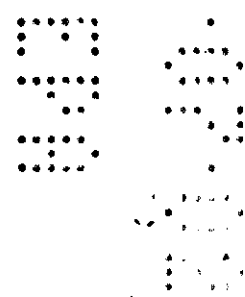
