4. You must generate studies corresponding to guidelines 830.6317 (one year storage stability) and 830.6320 (corrosion characteristics). You are required to generate the one year storage stability study under warehouse conditions. The observations must be made at 0, 3, 6, 9, and 12 months intervals. The corrosive characteristic study may be carried out concurrently. The results must be submitted to the Agency along with and electronic format also.

5. Please note that a notice of availability of EPA's registration eligibility document (RED) for product containing Permethrin was published in the FR on June 28, 2006 (Vol 71 No. 124 page 36788). Additional data and/or labeling changes may be required for products containing Permethrin.

6. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.
