DIRECTIONS FOR USE

If using over a bed, tuck the lower edge of the netting under the mattress to ensure a tight fit to prevent mosquitoes and other flying insects from entering, otherwise ensure that the base of the netting is in complete contact with the ground.

If netting becomes dirty, wash separately from other items, in warm water and allow to dry in shady area. Avoid sunlight when drying. Do not dry clean. Dry cleaning removes the active ingredient [permethrin].

Do not use for purposes other than originally intended. Do not retreat netting with other Permethrin insect repellent products.
