DIRECTIONS FOR USE

Hang netting up above [the bed] [or] [area to be protected] by suspending each corner [from the supports provided] [from the ceiling] [using the hooks provided]. If using over a bed, tuck the lower edge of the netting under the mattress to ensure a tight fit to prevent mosquitoes and other flying insects from entering, otherwise ensure that the base of the netting is in complete contact with the ground.

If netting becomes dirty, wash separately from other items, in warm water and allow to dry in shady area. Avoid sunlight when drying. Do not dry clean. Dry cleaning removes the active ingredient [permethrin].

Do not use for purposes other than originally intended. Do not retreat netting with other permethrin insect repellent products.

STORAGE AND DISPOSAL. When not in use, store netting in a cool, dry place away from children and direct sunlight. Dispose of outer packaging in trash. Discard in trash when netting is worn out.
