Your submission dated June 3, 2009

The application referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following comments:

1. Delete alternate brand names "Olyset Mosquito Protection System", "Olyset MP System", "Pramex Mosquito Protection System" and "Pramex PM System". It is not obvious what "MP" and "PM" stand for in the name. "Protection System" is vague.

2. Under Directions For Use add "It is a violation of Federal law to use this product in a manner inconsistent with its labeling.".

If using over a bed, tuck the lower edge of the netting under the mattress to ensure a tight fit to prevent mosquitoes and other flying insects from entering, otherwise ensure that the base of the netting is in complete contact with the ground.

If netting becomes dirty, wash separately from other items, in warm water and allow to dry in shady area. Avoid sunlight when drying. Do not dry clean. Dry cleaning removes the active ingredient [permethrin].

Do not use for purposes other than originally intended. Do not retreat netting with other permethrin insect repellent products.

STORAGE AND DISPOSAL. When not in use, store net [in outer packaging] in a cool, dry place away from children and direct sunlight. Discard of outer packaging and net in trash when net is worn out.

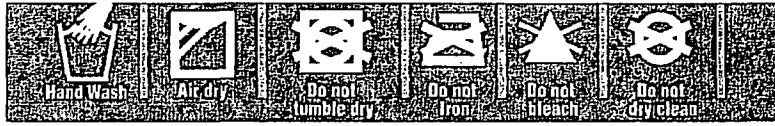
