- b. Change the Hazards to Humans and Domestic Animals section to read "Causes moderate eye irritation. Avoid contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.".
- c. Under First Aid you may delete the If Swallowed section. This is toxicity Category IV therefore this statement is not required.

- i. Delete "Knocks Down Instantly" and "Instant Knockdown Power". The data does not support these claims.
- j. Delete "This jet spray also kills insects that may return to the nest. In most cases, using this product prevents (stops) wasps and hornets from returning to the nest.". The data does not support this claim.
- k. Delete all references to Carpenter Bees. (Their behavior and nesting habits differs significantly from the wasp species on the label and the data submitted does not support this claim.).

- 1. Delete "Dual action: Kills and Repels.". The data does not support this claim.
- m. Move "[Because this] [product contains water] [is a water-based product,] Do not spray in or around electrical equipment to safeguard against possible shock hazard." to under Physical and Chemical Hazards.
- $\,$ n. Delete "Eliminates entire nest". Words or phrases indicating total or complete control are unacceptable.
- o. Delete the bullet "powerful" or qualify it by saying, "Powerful Jet Spray".
- p. Under "Important Read Before Use change " The directions for Use are believed to be adequate and should be..." to The directions for Use are believed to be adequate and must be..."

The Agency assigned a Toxicity Category III in terms of eye irritation potential because, unlike the cited products, the percentage of petroleum distillate is greater than 10%).

Spray at a safe distance from the nest and do not stand directly underneath it.

Aim the can away from you while spraying.

If it is breezy, spray with the wind at your back to avoid the spray drifting in your direction.

[Because this] [product contains water] [is a water-based product,] Do not spray in or around electrical equipment to safeguard against possible shock hazard.

To kill the entire nest, spray until it is soaked.

This jet spray also kills insects that may return to the nest. In most cases, using this product prevents [stops] wasps and hornets from returning to the nest.

Wait at least 24 hours before removing the nest.

To kill wasps, hornets, mud daubers, yellow jackets and bees under eaves, screens, window frames, doors, patios, cracks, holes or crevices wherever insects are noticed, directly spray insects for about 1 - 2 seconds.

This product may also be used indoors, in areas such as attics or crawl spaces where insects build nests. Whenever used indoors, follow directions for use carefully. Once nest is treated, leave the area quickly and close door behind you. Do not re-enter area for at least 24 hours to ensure all insects are killed.

Specific Instructions:

To Kill Wasps: Treatments should be made at dusk or early morning when insects are least active. Shake can and hold upright, pointing valve toward nest with wind at back.

To Kill Hornets: Hornets make their nests in trees and shrubs and under caves. Do not treat hornet's nests unless you can clearly see the entrance hole at the base. Wait until dusk or early morning when wasps are at rest. Direct spray into entrance hole and continue to spray into nest as wasps fall out until can is empty or no more wasps are seen. Quickly leave the area.

To Kill Yellow Jackets: Yellow jackets make their nests in tree stumps, walls, railroad ties or similar structures. Watch for wasn activity during the day to locate nest location. Treat at dusk or early morning when insects are a rest [in nest]. Empty entire contents of can into nest hole from close range to ensure product enters entrance hole and leave area immediately.

To Kill Mud Daubers: Treatments should be made at dusk or early morning when insects are least active. Shake can and hold upright, pointing valve toward nest with wind at back. Spray directly on insects and their nests.

To Kill Carpenter Bees: Locate area of infestation and/or insect tunnels and cavities. Spray into tunnels and galleries. Seal the entrance holes with small pieces of stainless steel wool after application.

To Kill Tent Caterpillars: Make applications when caterpillars are young and tents are first noticed (usually late spring). For best results, apply in the late afternoon or evening when caterpillars have returned to their tents. Aim spray directly at tents, and totally saturate on all sides.

To Kill Gypsy Moth Caterpillars: Make applications when caterpillars are young and first noticed (usually late spring). Spray plants evenly to the point of run-off, applying to both sides of leaves and other areas of plants where insects are suspected. For dense evergreens and shrubs, be sure spray reaches interior leaves and branches.

Do not apply to pets or contaminate feed, foodstuffs, dishes or utensils. Avoid spraying vegetation directly.
