Use Restrictions

In food areas of restaurants, residential, health care, educational, daycare, agricultural buildings, animal rearing and handling establishments, food handling and food processing establishments, this product may only be applied as a crack and crevice treatment. Any product remaining outside of cracks and crevices must be cleaned up and removed.

Application Directions

Use Sites: In and around residential, multi-family, commercial, industrial, municipal, institutional, research, recreational, health care, educational, daycare, hospitality and agricultural buildings and other man-made structures, garages, transport vehicles, sewers, animal rearing and handling establishments and food handling and food processing establishments.

How the Bait Works: Roaches live and breed where it is warm and dark and where there is access to food and food scraps. Small, confined spaces are very attractive. Cockroaches are attracted to InTice Roach Bait. They feed on the bait and most will return to their normal habitat to die. Others may die closer to the bait.

Place bait in the kitchen and other areas where roaches are likely to be found, such as the laundry and bathroom, and any other areas that offer a warm, dark, moist, secluded environment - such as behind sinks, cupboards, refrigerators, stoves, hot water systems and washing machines. Use pea-sized placements. For heavier infestations, use a larger number of pea-sized placements. Heavier infestations may require a re-application of bait. Place bait in areas inaccessible to children and pets, or in tamper-resistant bait stations. Avoid contamination of foodstuffs. Do not place bait where food is being prepared or on utensils that are used for food preparation.

Food Processing and Handling Establishment Application, including Federally-Inspected Meat and Poultry Plants: Follow instructions for other sites as appropriate. In food areas, only apply bait in cracks, crevices, and other inaccessible areas. Avoid untamination of food and feedstuffs. Never apply bait directly to a surface where food is stored, prepared or served. Any bait that is left visible after treatment should be removed and the exposed surface washed.
