- a. Remove the following claim: Weather/Moisture Resistant Bait. You must submit efficacy data to demonstrate that this claim is efficacious for the duration of the product. This data must be reviewed and approved by the Agency.
- b. Delete cockroaches from your product labeling for the following reasons:
  - No directions for use for cockroaches
  - The use sites on this label are not the same as the cockroach use site on the cited label
- c. The following pest listed below can not be added to this product label without data being accepted by the Agency:
  - Carpenter Ants
  - Fire Ants
  - Pharaoh Ants
  - Harvester Ants

Ants may be included, and must be listed as follows:  
Ants, (Except Pharaoh Ants, Carpenter Ants,  
Fire Ants, Harvester Ants).

- d. Revise the Precautionary Statement to read as follows:  
"Harmful is absorbed through the skin. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Wash hands before eating, drinking, chewing gum, using tobacco or using he toilet."

These studies must be provided to the Agency within 18 months from the date on initial registration for this product.

### Application Directions

**Use Sites:** lawns, landscape beds, ornamental turf, parks, playing fields, right-of-ways, golf courses, home greenhouses, and interiorscapes.

Apply bait evenly over the affected area using a hand shaker or mechanical spreader at a rate of 1 lb per 1000 square feet or 45 lbs per acre. The product should not be watered in. For mole cricket treatments, results will be best if the area is irrigated prior to bait treatment. Mole crickets typically come to the surface to feed in the evening. Individual ant mounds may be treated by sprinkling 1/2 oz of product around each mound. For snails and slugs apply early in the season to areas likely to be infested and repeat monthly for satisfactory control. In home greenhouses, evenly spread bait at a rate of 3 oz per 100 sq ft on and under benches. Keep off of flats and pots. In fruit or vegetable gardens, or interior landscaped areas, spread the bait at a rate of 3 oz per 100 sq ft and repeat no more than once every 4-6 weeks.

### Storage and Disposal

Do not contaminate water, food or feed by storage or disposal.

**Storage:** Store in a dry place. Do not store where children or animals may gain access.

**Disposal: If empty:** Do not reuse this container. Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency or **1-800-CLEANUP** which is managed as a public-private partnership.
