The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Permethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

# **DIRECTIONS FOR USE**

It is a violation of federal law to use this product in a manner inconsistent with its labeling. For outdoor use only.

#### **USE RESTRICTIONS**

- Apply this product only as specified on this label.
- Do not contaminate food or feed stuffs.
- Do not make applications with a sponge.
- Do not breathe spray mist.
- Do not use this product directly on domestic (companion) animals (dogs, cats, puppies, or kittens).
- This product is not for use in outdoor residential misting systems (indoor or outdoor), or in metered release misting systems.
- Except when applying to livestock, do not apply this product in a way that will contact workers or other persons, either directly or through drift.
- Except when applying to livestock, do not enter or allow others to enter treated area until sprays have dried.
- Except when applying to livestock, only protected handlers may be in the area during application.
- Remove or cover exposed food/feed and drinking water before application.
- When used in milking parlors or tank rooms: Close milk bulk tank lids to prevent contamination from spray and from dead or falling insects. Remove or cover milking utensils before application. Wash teats of animals before milking.
- Remove pets, birds, and cover fish aquariums and ornamental fish ponds before spraying, and turn aquarium systems off prior to use.
- Do not apply the product into fish pools, ponds, streams, or lakes. Do not apply directly to sewers or storm drains, or to any area like a drain or gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur.
- Do not allow the product to enter any drain during or after application.
- Do not apply directly to impervious horizontal surfaces such as sidewalks, driveways, and patios except as a spot or crack-and-crevice treatment.
- Do not apply or irrigate to the point of runoff.

READY TO USE – No dilution necessary.

All outdoor spray applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1) Application to pervious surfaces such as soil, lawn, turf, and other vegetation;

- 2) Perimeter band treatments of 7 feet wide or less from the base of a man-made structure to pervious surfaces (e.g., soil, mulch or lawn);
- 2) Applications to underside of eaves, soffits, doors, or windows permanently protected from rainfall by a covering, overhand, awning, or other structure;
- 3) Applications around potential exterior pest entry points into man-made structures such as doorways and windows, when limited to a band not to exceed one inch;
- 4) Applications to vertical surfaces (such as the side of a man-made structure) directly above impervious surfaces (e.g., driveways, sidewalks, etc.), up to 2 feet above ground level;
- 5) Applications to vertical surfaces directly above pervious surfaces, such as soil, lawn, turf, mulch or other vegetation) only if the pervious surface does not drain into ditches, storm drains, gutters, or surface waters.

Spot treatments must not exceed two square feet in size (e.g., 2 ft x 1 ft or 4 ft x 0.5 ft.) Treat surfaces to ensure thorough coverage but avoid runoff. To treat insects harbored in voids and cracks-and-crevices, applications must be made in such a manner to limit dripping and avoid runoff onto untreated structural surfaces and plants.

For soil or foliar applications, do not apply by ground within 25 feet of lakes, reservoirs, rivers, permanent streams, marshes or natural ponds, estuaries and commercial fish farm ponds.

Do not make outdoor applications during rain. Avoid making applications when rainfall is expected before the product has sufficient time to dry (minimum 4 hours). Rainfall within 24 hours after application may cause unintended runoff of pesticide application.

#### SPRAY DRIFT ADVISORIES

Handheld Technology Applications: Take precautions to minimize spray drift.

For resistance management, this product contains a Group 3A insecticide. Any insect/mite population may contain individuals naturally resistant to this product and other Group 3A insecticides/acaricides. The resistant individuals may dominate the insect/mite population if this group of insecticides/acaricides are used repeatedly on the same livestock. Appropriate resistance-management strategies should be followed. To delay insecticide/acaricide resistance, take the following steps:

- Rotate the use of this product or other Group 3A insecticides/acaricides within a season with different groups that control the same pests.
- Use tank mixtures with insecticides/acaricides from a different group that are equally
  effective on the target pest when such use is permitted. Do not rely on the same mixture
  repeatedly for the same pest population. Consider any known cross-resistance issues
  between the individual components of a mixture. In addition, consider the following
  recommendations provided by the Insecticide Resistance Action Committee (IRAC):

- Individual insecticides selected for use in mixtures should be highly effective and be applied at the rates at which they are individually registered for use against the target species.
- Mixtures with components having the same IRAC mode of action classification are not recommended for insect resistance management.
- When using mixtures, consider any known cross-resistance issues between the individual components for the targeted pest(s).
- Mixtures become less effective if resistance is already developing to one or both active ingredients, but they may still provide pest management benefits.
- The insect resistance management benefits of an insecticide mixture are greatest if the two components have similar periods of residual insecticidal activity. Mixtures of insecticides with unequal periods of residual insecticide activity may offer an insect resistance management benefit only for the period where both insecticides are active.
- Adopt an integrated pest management program for insecticide/acaricides use that includes scouting, uses historical information related to pesticide use, record keeping, and which considers cultural, biological and other chemical control practices.
- Monitor after application for unexpected target pest survival. If the level of survival suggests
  the presence of resistance, consult with your local university specialist or certified pest
  control advisor.
- Contact your local extension specialist of certified crop advisors for any additional pesticide resistance management and/or IPM recommendations for the specific site and pest problems in your area.

APPLICATION INSTRUCTIONS: Apply ¼ fluid ounce per 100 pounds body weight of animal, up to a maximum of 2.5 fluid ounces for any one animal to kill Lice Horn Flies and Face Flies. Aids in insecticidal control of Horse Flies, Stable Flies, Mosquitoes, and Black Flies on lactating and nonlactating dairy cattle, beef cattle, calves, and sheep. For sheep, apply 1/8 fluid ounce per 50 pounds body weight of animal, up to a maximum of 1.5 fluid ounces for any one animal. Pour-On: Pour along back line and down face. For Keds \*on sheep\*, pour along back line over neck, shoulders, and rump. Ready-To-Use Spray: Use undiluted in a mist sprayer to apply correct dose. Apply directly to neck, face, back, legs, and ears. For PourOn and Ready-To-Use Spray applications, repeat treatment as needed but do not exceed 2.5 fluid ounces for any one animal on cattle or 1.5 fluid ounces for any one animal on sheep during any 14-day interval. For optimum insecticidal effectiveness against lice, a second treatment at 14-day intervals is recommended. Back Rubber Use: Mix ½ pint per gallon #2 diesel or mineral oil. Keep rubbing device charged. For Back-Rubber applications, results are improved by daily forced use. For cattle and sheep, repeat treatment as needed, but not more often than once every two weeks. For optimum lice control, two treatments at a 14-day interval are recommended. Special Note: This product is not effective in controlling cattle grubs. This product is an oil-based, ready-to-use product that may leave an oily appearance on the hair coat of some animals.

\*Not registered in the State of California for control of Sheep Keds and Lice on Sheep.

#### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.
