(7.5 lb. per 7,500 to 15,000 sq. ft.; 5.5 lb. per 5,500 to 11,000 sq. ft.) For best results, apply when ants are active (typically when soil temperature is greater than 60°F). Repeat application as needed.

This product controls imported and native fire ants and other ants, such as harvester ants, bigheaded ants, and Argentine ants. This product is for use ONLY on lawns, landscaped areas, golf courses, commercial grounds, parks and other noncropland areas, as well as on grounds surrounding poultry houses (excluding runs and ranges) or corrals and other animal holding areas. Avoid direct exposure of animals to this product.

Do not graze or feed treated lawn or sod clippings to livestock.

This product is not for use on vegetable or other food crops, timber or plants grown for sale or other commercial use, or for commercial seed production, or for research purposes.
