

 - B. To the "Ingredient Statement" delete the asterisk (*) appended to the sentence "* Each formulator...." The reference made by the foregoing appears ambiguous, since it is inconsistent with the (*) previous usage relating the "active ingredient" with the "metallic copper equivalent percent."

- C. Replace "should" with "must," in the subsection "Pesticide Storage," which provides the user with deliberate product guidance.
- D. To the subsections "If Swallowed" and "If Inhaled," change "Call poison control..." to "Call a poison control..."
- E. Delete "Foot baths for cattle," as this is a FDA use, which is not permitted on EPA labels. Such uses are not allowed for new copper products. Existing products will be required to remove such use(s) upon product re-registration.
- F. List all intended "ornamentals," or delete the term altogether.
- G. Instead of using "To the extent...permitted by applicable law...," in the "Warranty Statement," it is required that you observe "To the extent...consistent with applicable law...."
- 3. For the section "Directions for Use," replace the statement "For use in formulating..." with "Only for formulation into...."
- 4. In the "Directions for Use" section, include the Environmental Hazards statements as required by the "Copper RED," dated July 2006. It reads "This pesticide is toxic...invertebrates. Do not discharge...National Pollutant Discharge Elimination System (NPDES)...discharge. Do not discharge...authority. For guidance...EPA. Do not contaminate...washwaters or rinsate."

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release of the shipment of your product constitutes acceptance of these conditions.

PRECAUTIONARY STATEMENTS HAZARD TO HUMANS AND DOMESTIC ANIMALS DANGER
