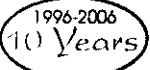

[(3.0 ml applicator tubes) Apply approximately half of the tube (1.5 ml/0.05 fl. oz) of this product as a spot or stripe to the dog's back between the shoulder blades and apply the rest of the tube's contents (1.5 ml/0.05 fl. oz) as a spot or stripe to the dog's back directly in front of the base of the tail.]

OR

[Apply the entire tube (3.0 ml/0.1 fl. oz.) [of this product] as a continuous stripe on the dog's back starting between the shoulder blades and ending directly in front of the base of the tail.]

[For Dogs Weighing 66 lbs and Over: (1.5 ml applicator tubes) Apply one tube (1.5 ml/0.05 fl. oz) of this product as a stripe to the dog's back between the shoulder blades and apply a second and a third tube (two 1.5 ml/0.05 fl. oz tubes) continuing the stripe down the center of the dog's back and apply a fourth tube (1.5 ml/0.05 fl. oz) to the dog's back directly in front of the base of the tail.]

OR
