"Apply enough product to provide a continuous barrier around the perimeter or circumference of the application surface, and in such a manner that no space exists between the product and the surface to which it is being applied. Do not place product in exposed locations where there is likely to be direct contact with children or pets."

It appears the labeling submitted is for the cardboard box that contains the plastic bags. Please submit labeling for the plastic bags.

3. Please submit two (2) copies of your final printed label for before your release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label and efficacy review are enclosed for your records.
