[ARINIX[®]][ARINIX[®] Tip] effectively repels Red Imported Fire Ants, spiders (except Black Widow and Brown Recluse), ants (except carpenter and pharaoh), beetles, moths, and silverfish. [ARINIX[®]][ARINIX[®] Tip] is available in several shapes and sizes and can be used in applications in which prevention of the above pests is needed. Examples of applications include AC cable or power line cords, base or door trim on electrical power supply boxes, transmitter boxes and vending machines, transformer, control relay wiring boards, security or fire alarms, monitoring cameras and sensors, ventilation openings around building foundations, home or office ventilation security, home or office entrance, exit, window or cargo door, sewage and sewer or drainpipes, electrical switches and sensors used to control irrigation devices, lighting and HVAC systems.
